Day 01	Delhi – Paro-Thimphu	Departure from Delhi at 1230 hr and arrival at Paro at 1540 hrs. Meet local representative at the airport. Proceed to Thimphu. Enroute experience some amazing scenic views of mountains and River Flowing along. On reaching Thimphu, check-in to your hotel, and rest of day is at leisure. In the evening, have dinner in your hotel.(D)
Day 02	Thimphu	Breakfast at the hotel. Proceed for local sightseeing covering some major attractions of Thimphu: <b>Simtokha Dzong</b> : Monastery was built in 1627 by Zhabdrung Ngawang Namgyal. <b>Memorial Chorten( outer view)</b> It is also known as the Thimphu Chorten, is a Chorten in Thimphu, Bhutan located on Deo boom Lam. <b>Kuensal Phodrang</b> : The largest statue in the country and then walk around and take a glimpse of the valley. Post Lunch explore Thimphu on your own and Transfer to hotel by evening. Dinner at hotel. Overnight stay in Thimphu. (B+L+D)
Day 03	Thimphu - Punakha	Breakfast at hotel. Check out from hotel. Proceed to Punakha. Enroute take a photo stop at <b>Dochula view point</b> , to experience the glimpse of Himalayan range, On your way to Punakha visit , <b>Punakha Dzong and Suspension Bridge</b> . Dinner at Hotel and Overnight stay at Punakha.(B+L+D)
Day 04	Punakha - Paro	Breakfast at hotel. Checkout from Punakha and proceed to Paro. En-route visit Lamperi Royal botanical Park-The park is planted with 46 species of rhododendron of which 18 species are native to the park while the other 26 species are brought from other regions of Bhutan and planted here. Visit Tamchog Lhakhang iron bridge-Tamchog Lhakhang sits across the Paro River. Lhakhang is approached by an iron chain suspension bridge. On reaching Paro, have lunch on your own in local restaurants and later proceed for sightseeing to <b>Kyichulhakhang</b> “one of the oldest Temples in Bhutan”. Dinner at Hotel and overnight stay in Paro. (B+L+D)
Day 05	Paro	After Breakfast, proceed from hotel to visit famous <b>(Tiger’s Nest Temple) base point-</b> The most famous of Bhutanese monasteries or excursion to <b>Chele La Pass</b> .In the evening return to hotel and enjoy dinner. Overnight stay at hotel in Paro. (B+L+D)
Day 06	Paro - Delhi	After Packed Breakfast, Early check out and transfer to Paro International Airport to catch return flight wherein Departure from Paro to Delhi at 0940 hrs.Arrival at Delhi @ 1130 HRS.
