Tour Itinerary: Hyderabad – Srinagar – Gulmarg – Sonmarg – Pahalgam Srinagar- Hyderabad (05 nights/06 days)

Day 1:	Hyderabad to Srinagar	Depart from Hyderabad. On arrival at Srinagar Airport Pick up and Transfer to Hotel and check-in. Evening free at your own. Dinner & Overnight in Srinagar at Hotel.	Srinagar
Day 2:	Srinagar- Sonmarg- Srinagar	After breakfast leave from Srinagar and drive towards Sonmarg. Sonmarg (2800Mtrs above sea level), which means ' meadow of gold ' has, as its backdrop, snowy mountains against a cerulean sky. The Sindh meanders along here and abounds with trout and mahseer, snow trout can be caught in the main river. The visitors can have access to snow which is furnished all over like a white carpet. Ponies can be hired for the trip up to Thajwas glacier a major attraction during the summer months. In the evening return back to Srinagar. Dinner & Overnight in	Srinagar

Day 3:	Srinagar- Gulmarg- Srinagar	After breakfast leave for Gulmarg-"Meadows of flowers by road transport. Gulmarg is famous because of its "Gulmarg Gondola," one of the highest cable cars in the world (<i>Guests must book their Gondola ride tickets online</i>). A short trek up to Khilanmarg (optional at guest own cost). Drive back to Srinagar. Dinner & Overnight in Srinagar at Hotel. N.B- The coach will transfer you up to the Tourist Bus parking in Gulmarg. Day 4:	Srinagar- Pahalgam - Srinagar	After breakfast checkout from hotel, day trip to Pahalgam. Pahalgam 2440 Mtrs above sea level (Valley of Shepherds) on the way visit Saffron fields & Avantipur ruins. Pahalgam is the most famous place for Indian Film Industry. Enjoy the nature charm of the valley. One can visit Betaab Valley, Chandanwari and Aru Valley in Pahalgam (<i>Direct payment basis</i>). In the evening check into hotel at Pahalgam. Dinner & overnight at Pahalgam. N.B- The coach will transfer you up to the Tourist Bus parking in Pahalgam. Thereon, you may visit the sightseeing places by jeep/pony on your own payment.	
Day 5:	Pahalgam - Srinagar	After breakfast checkout from hotel and proceed to Srinagar. Then visit of the famous Shankracharya Temple for darshan. In the evening, Shikara ride on Dal Lake to enjoy sunset and view of Char-Chinar (Floating Gardens) at own cost. Evening checkin in house boast Dinner and night stay at Houseboat.	Srinagar

General Guidelines to the Passengers:

- 1. All prices mentioned are 'Per Person'.
- 2. The package Price is subject to change without prior notice.
- 3. The mentioned package price is as on date of booking. However, in case of increase in input costs such as GST, hotel room rates levy by the hotel especially during peak season / holiday surcharge and major events/ fairs and convention or any other expenses beyond the control of IRCTC, the guests are liable to pay the additional amount before commencement of journey.
- 4. In case any of the sightseeing spot mentioned in the itinerary remains closed due to local reason, IRCTC will arrange for alternative sightseeing spot. All guests are requested to cooperate in this regard.





- 5. Alternate Arrangements will be made disruption of tour on account of natural calamities and the cost to be borne by the tourist.
- 6. IRCTC has right to alter itinerary under unavoidable circumstances and is not liable for any type of natural calamities/ strikes/ cancellations/ delay of flight/insurgency of any such nature which is beyond control during the tour period.
- 7. Covering all sightseeing places are subject to time availability, weather & road conditions. All sightseeing places are subject to opening of tourist destinations and time availability.
- 8. The decision of IRCTC/SCZ will be final on account of problems arising in the conduct of the tour.
- 9. The guests are requested to take care of their personal belongings carefully and avoid leaving them unattended.
- 10. Management is not accountable for any theft or damage of luggage during the trip.
- 11. Arrangements will be made for medical attention during sickness while on tour and the cost will borne by the tourist.
- 12. Package operation is subject to government guidelines at the destinations.
- 13. Allotted time slots by any facility/tourist attraction/activity should be followed by all tourists for the convenience of service providers and other tourists.
- 14. IRCTC will not be responsible if the tourists do not abide by the safety guidelines and get penalized by concern authorities for violating the same.
- 15. Passenger should call any queries about the tour from IRCTC before/after the booking to avoid any confusion.

Hotels:

- 1. Final confirmation in the proposed hotels is subject to the availability at the time of booking, else similar category hotel will be provided.
- 2. Room categories in all packages are the base category rooms unless stated otherwise.
- 3. The request for an adjacent or an adjoining room will be on subject to availability only and will incur extra charges if adjoining room is of higher category.
- 4. Room allocation (Twin bed / Double bed) is at the discretion of the hotel. The check in and check out time of the hotel is fixed as per Hotel Guidelines. Numbers of meals are always corresponding to the number of nights booked. Breakfast is not provided on the day of arrival.
- 5. In hotels for an extra Adult / Child either Rollaway bed or mattress shall be provided.
- 6. Three person of one family on one booking will be accommodated in one double room with an extra Mattress.
- 7. Child will be accommodated in one room with the parents only.
- 8. Payments pertaining to early check- in, late check-out, items consumed in Room Minibar and any extra services of hotel other than mentioned in the package are to be settled at hotel directly by the guest.
- 9. Hotel has the right to claim the damages incurred by any of the guest.

Transfers and Sightseeing:

- 1. Transfers and Sightseeing tours are on sharing basis.
- 2. Arrival / departure transfers & sightseeing tours shall be provided as per schedule fixed by the IRCTC. However this may require you to wait at the airport/destination for short duration until arrival of all the guests.
- 3. Vehicle is not on personal disposal basis. Vehicle will be provided as per the schedule of the itinerary.





- 4. Tour Vehicle will be allotted based on number of adults booked for the tour.
- 5. Category of the vehicle will be decided as per the group size.

Force Majeure

'Force majeure' means any event which we / the supplier of the service(s) in question / the Third Party Supplier could not, even with all due care, foresee or avoid. Such events may include disruptions/diversions of rail services, floods, earthquakes, whether actual or threatened war, riot, civil strife, actual or threatened terrorist activity, industrial dispute, natural or nuclear disaster, adverse weather conditions, disease, fire and all similar events outside the control of the party concerned.

We cannot accept liability or pay any compensation where the performance or prompt performance of our obligations under our agreement with you is prevented or affected by, or you otherwise suffer any damage or loss as a result of, 'force majeure'.

Our Liability To You:

IRCTC will not be responsible for any injury, illness, death, loss, damage, expense, cost or other claim of any description whatsoever which results from:

- The act(s) and / or omission(s) of the person(s) affected or any member(s) of their party
- The act(s) and / or omission(s) of a third party not connected with the provision of your arrangements and which were unforeseeable or unavoidable; or Any service or facility not arranged by us as part of our contract with you; or 'force majeure' as defined above.

Payments and Confirmation:

- 3. The IRCTC reserves the right to decline your booking for any Tour or to cancel your booking without assigning any reason.
- 4. Guest has to strictly follow the tour program. Guests are responsible to register with the representative of the Company at the appointed date, place and time and would be treated as





- a no-show if fail to do so. Under no circumstances would any refund be given for any unutilized services.
- 5. In case of partial cancellation please note that occupancy conversion charges will be applicable.
- 6. In case of cancellation of Counter bookings, copy of pan card of the guest in whose name refund is claimed shall be required.
- 7. Changes and Cancellation by IRCTC prior to your departure: The journeys are planned well in advance. We reserve the right to make changes to the programme if necessary at any point of time. Should the minimum number of passengers not be met or due to certain operational reasons and conditions, we reserve the right to cancel the departure or amend the same. Most changes made by us would be minor, but on certain occasions there could be a possibility of making a significant change. A change is defined as significant if it involves a change of destination or date of departure. In such an eventuality, we would inform you as soon as possible and provide you with the following solutions:
 - a. Accepting the changed arrangements or
 - b. Cancelling or accepting the cancellation where you will receive a refund of the payment remitted to us.

However, there will be no refund for any service such as pre / post accommodation, airline tickets, excursions, extensions etc. that have been booked by you and / or your Travel Agent.

While Boat Cruising, either arranged in the package by IRCTC/self(own) anywhere as specified in the itinerary, please do not venture out into the Lake/River/Canal without informing the crew available on the Boat. Please abstain from doing anything that rocks the boat. Please do not lean over the side which might distort the boat. Please do not swim in the lake/river/canal.
